

SAVEONENERGY RETROFIT PROGRAM

UPGRADE YOUR EQUIPMENT AND SAVE ON ENERGY COSTS!

WHAT?

The Retrofit program provides incentives to replace inefficient equipment and upgrade to energy efficient equipment. The program consists of two different tracks:

1. Prescriptive Track – Prescriptive Track – Quick system upgrades. Incentives based on predefined amounts with easy applications to follow!
2. Custom Track – For flexible, more comprehensive projects. Incentives based on energy savings over pre-project baselines.

WHAT KIND OF PROJECTS CAN I RECEIVE FUNDING FOR?

- Measures that provide sustainable, measurable and verifiable reductions
- Lighting retrofits, lighting controls
- HVAC redesign
- Variable speed drives
- Building envelope/ improved thermal performance
- Implementation of new operating procedures



Prescriptive

Lighting	Per unit incentive
Non-lighting (including lighting controls)	Per unit incentive

Custom

Lighting	Per unit incentive
Lighting including lighting controls	The greater of either, \$400/kW of demand savings or \$0.05/kWh of first year electricity savings
Non-lighting	The greater of either, \$800/kW or \$0.10/kWh of first year electricity savings
Multi-Family: tenant education	\$200/kW of the estimated demand savings, and to a maximum of 10% of the incentives paid for the equipment replacement project
Social housing	Advance 50% of eligible financial incentive funding before project starts and after project approval by your electricity provider. Gap grant funding: Double the participant incentive capped at 50% of project cost.

SAVEONENERGY RETROFIT PROGRAM

WHO?

Retrofit incentives for commercial, industrial, agricultural or institutional facilities are available for owners or lessees of:

- Commercial spaces or buildings such as offices, retail, grocery, restaurants, hotels, warehouses;
- Industrial facilities in sectors such as food and beverage, automotive, plastics and packaging industries;
- Institutional buildings such as hospitals, universities, municipal halls and arenas;
- Multi-family buildings, such as apartments (including low income and social housing) or condominiums;
- Agricultural facilities such as dairy, swine and poultry farms, greenhouses and nurseries.

HOW?

1. Contact your electricity provider to help determine your eligibility and to provide you with relevant documents;
2. Decide on whether the prescriptive or custom track application is right for your energy saving project – your electricity provider can help you with this;
3. Have your electricity provider approve your project before advancing (ALL PROJECTS MUST BE PRE-APPROVED TO PARTICIPATE);
4. Once approved, create a SaveOnEnergy account (visit RetrofitMyBusiness.ca) and ask your electricity provider for assistance in finding a qualified contractor;
5. Complete work, update project paperwork online and invoice your ELECTRICITY PROVIDER for the final amount of the incentive (electricity providers pay incentive after receiving approval from the Independent Electricity System Operator [IESO]).
